The comments must address the standards and criteria that apply to the application and submitted within 15 days from the date of this notice in order to be considered.

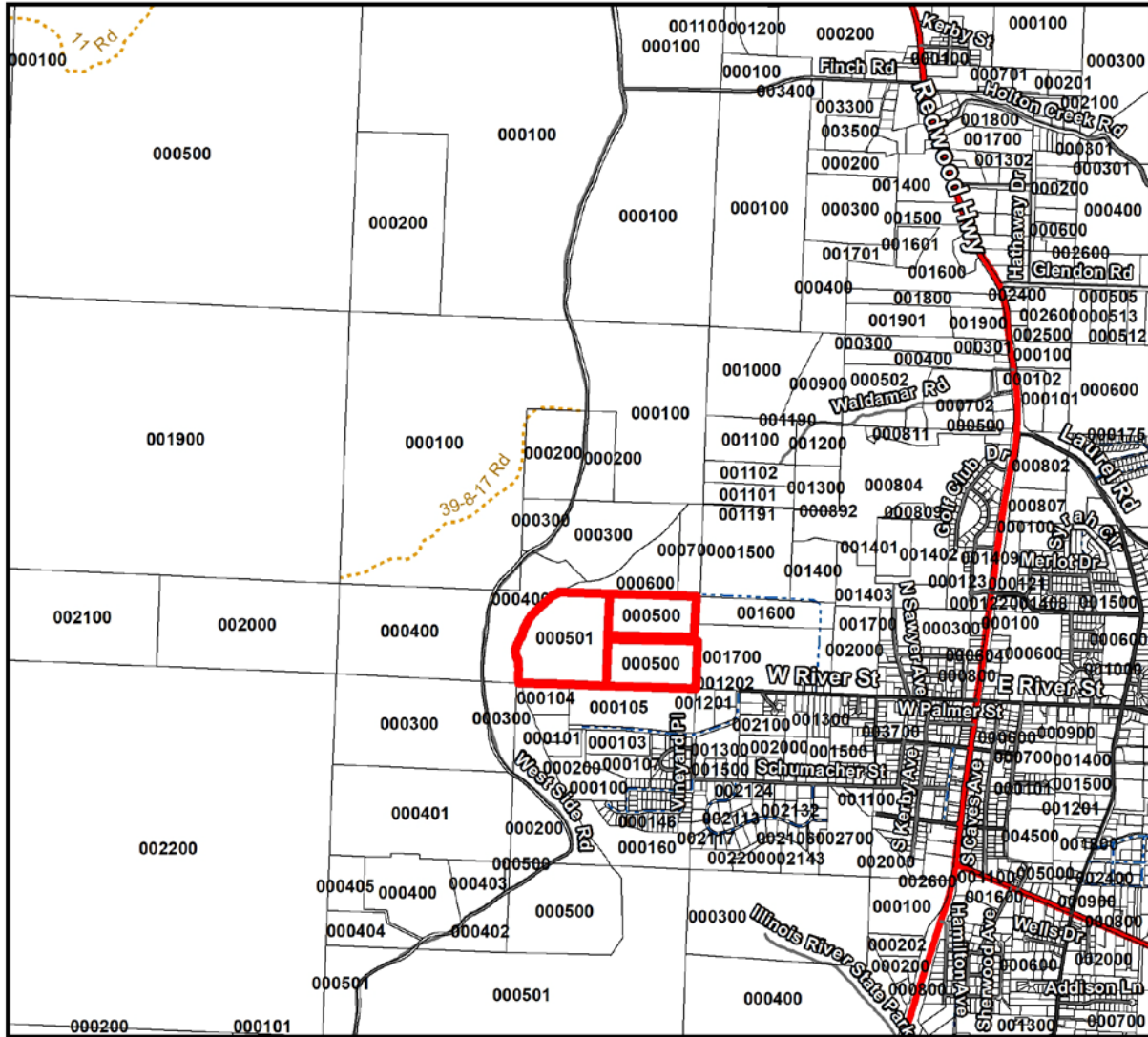

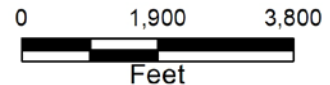
