NOTICE OF PUBLIC HEARING

SUBJECT: The JOSEPHINE COUNTY BOARD OF COMMISSIONERS, in accordance with the Land Use Hearing Rules, will conduct a public hearing for the first reading of Ordinance No. 2018-003 described as follows:

ORDINANCE NO. 2018-003; AN ORDINANCE TO AMEND THE JOSEPHINE COUNTY RURAL LAND DEVELOPMENT CODE (ORDINANCE 94-4, AS ORIGINALLY ADOPTED AND SUBSEQUENTLY AMENDED) TO IMPLEMENT CERTAIN CHANGES RELATED TO HOUSING AND DEVELOPMENT: AMEND ARTICLE 11, DEFINITIONS; AMEND ARTICLE 41 TO ALLOW FOR EMERGENCY PERMITTING; AMEND ARTICLE 43 REGARDING MEDICAL HARDSHIPS AND DETACHED LIVING SPACES, AND, TEMPORARY STORAGE OF MOBILE HOMES; AMEND ARTICLE 51 TO CREATE CLUSTER SUBDIVISION REGULATIONS; AMEND CHAPTER 6 TO ALLOW BOARDING HOUSES, FARM STAYS, TRANSITIONAL HOUSING, DETACHED LIVING SPACE, RETREAT CENTER, HOSTEL, TOURIST HOME, TRANSIENT HOUSING SHELTER, TEMPORARY STORAGE OF MOBILE HOME, TRANSITIONAL HOUSING CAMPS, AND DELETE GUESTHOUSES; AMEND ARTICLE 70 REGARDING UNIQUE STRUCTURES, COMPLIANCE WITH SPECIALTY CODES, AND LIMITING COLOR; AMEND ARTICLE 71 REGARDING CONFORMING PARCELS, ROAD EASEMENTS, AND FLAGLOTS; AMEND ARTICLE 72 BY CREATING A PRIVATE ROAD SETBACK; AMEND ARTICLE 81 REGARDING PRIVATE ROADS AND ROAD EASEMENTS; AMEND ARTICLE 83 REGARDING EROSION CONTROL AND STORMWATER MANAGEMENT; AMEND ARTICLE 90 REGARDING UNIQUE STRUCTURES, COMPLIANCE WITH SPECIALTY CODES, AND LIMITING COLOR; AMEND ARTICLE 92 TO CREATE FARM STAYS; AMEND ARTICLE 98 REGARDING CAMPING AND CAMPING DURING CONSTRUCTION; CREATE ARTICLE 99 TO ALLOW FOR TRANSITIONAL HOUSING, TRANSITIONAL HOUSING CAMPS, AND TRANSITIONAL HOUSING SHELTER; AMEND THE TABLE OF CONTENTS AND USE INDEX TO REFLECT THE ABOVE AMENDMENTS.
